



2009 BIKE RENTAL AGREEMENT

This agreement is an integral part of the 2009 Membership Application

The Calgary Bicycle Track League (CBTL) agrees to permit the exclusive use of a rental track bike during all CBTL scheduled events for one season, including training and racing sessions. The Calgary Bicycle Track League will, adjust, maintain and make minor repairs that may be necessary due to normal wear and tear.

- I, the undersigned, agree that I am responsible for the rental Track Bike that is assigned to me. I agree to keep the bike in good condition and treat it with care. I understand that I am ultimately liable for any costs arising from repairs that the CBTL judges to be beyond the scope of normal wear and tear, such as misuse, negligence, abuse or purposeful damage, regardless of cause, that occur during my use of the bicycle.
- I, the undersigned, understand that this bike will be available to me for all CBTL scheduled events for the entire season. However, this bike remains the property of CBTL, and may be used by the CBTL for instruction and/or training outside of CBTL scheduled events. The Calgary Bicycle Track League reserves the right (i) to refuse bike rental to any rider by refusing their Rental Fee, and (ii) to recall any unused rented bikes, after contacting the renter. I acknowledge that signing this agreement is a necessary condition of renting a Track Bike from the CBTL.
- I, the undersigned, agree to **not remove, modify or trade parts** on any rental bikes, with the exception of pedals. I am allowed to install a bicycle computer, at my own risk. If I wish to substitute cogs or chainrings, I will consult with the Equipment Manager. I understand that the CBTL is not responsible for any loss or damage to any personal property that is installed on a rental bike. ***If the rented bike is not returned in the exact condition, with the same componentry, as it was rented, I am responsible for the replacement of parts and the mechanic's time (labour) to restore the bike to its original condition.***
- I, the undersigned, agree to inform the Equipment Manager immediately of any condition in which, in my opinion, the rental bike may be considered as damaged, unsafe or unusable. I agree that it is my responsibility to conduct an immediate inspection of the bike prior to use, and to inform the Track Manager or CBTL Mechanic of any damage or missing parts.
- I, the undersigned, agree to not remove any bikes from the Glenmore Velodrome. I acknowledge that I am permitted to take my assigned rental bike to races, competitions or activities held at other facilities provided that (i) I obtain **written permission** from the Equipment Manager or a member of the CBTL Executive; (ii) I return the bike to the Glenmore Velodrome as soon as possible.

BY CHECKING THE INDIVIDUAL BOXES, SIGNING AND SUBMITTING THIS AGREEMENT, I ACKNOWLEDGE HAVING READ, UNDERSTOOD AND AGREED TO EACH POINT OF THE ABOVE RULES AND CONDITIONS.
